The Republic of Serbia plans to improve navigational conditions on the Sava River to further develop the inland water transport and improve its efficiency for the movement of good and people. The work is divided into two sections: Section 1: River training works with the construction of the hydrotechnical structures on the Sava River from km 178+200 to km 183+200 and Section 2: dredging of the Sava River sediment on the inland waterway from km 170+000 to km 188+000. The contract will be implemented under Conditions of Contract for Construction for Building and Engineering Works Designed by the Employer (FIDIC, Red Book), Second Edition 2017. Financing – requested EIB support (subject to confirmation) through Finance Contract for Serbian Inland Waterway Infrastructure between the Republic of Serbia and EIB (Official Gazette of RS, No.2/19) and budget of the Republic of Serbia.
