The scope of the Works Contract refers to removal of 21 sunken vessels from the WW2 from the Danube River near Prahovo (km 862-857), lying in the area containing a number of identified UXO. The

project's purpose is to ensure fairway parameters for safe inland navigation, according to the international waterway Class VII requirements.
