The Republic of Serbia has received financing in the amount of USD 130,000,000 equivalent from the World Bank and the Agency Francaise de Development toward the cost of the Phase 2 of the Multi-phase Programmatic Approach Serbia Railway Sector Modernization Project (SRSM-Phase 2), and intends to apply part of the proceeds to payments for goods, works, non-consulting services and consulting services to be procured under this project.

The project will include the following components:

Component 1: Infrastructure Investments and Asset Management

Component 2: Institutional Strengthening and Project Management

Component 3: Railway Modernization Enablers

Description of project components to be procured through Request for Bids and Consultants Quality and Cost-based Selection:

- Heavy duty track maintenance machinery (tamping machines and ballast regulator);
- Wagons and Dresines;
- Monitoring equipment and motorcars;
- Heavy-duty track-bound crane (auxiliary train for emergency situations);
- Repair and refurbishment of out-of-order heavy-duty machinery;
- Repairs of workshop buildings (2 locations);
- Equipment for maintenance facilities (cranes, lifting jacks, turntables);
- Contracting railway routine maintenance;
- Railways Infrastructure Asset Management System (RIAMS) - follow up activities;
- Technical design and E&S instrument for the rehabilitation of railway lines;
- Ticketing and business support systems for Serbia Voz;
- Marketing Strategy for Serbia Voz - follow up activities;
- Serbia Cargo business support systems - follow up activities;
- Development of a Strategy for logistics centers and assessment of last mile connectivity investments;
- The Integrated Territorial Development (ITD) pilot projects - follow up activities from Phase 1;
- Business plan for railways stations in Serbia.

Procurement will be conducted in accordance with the World Bank's Procurement Regulations for IPF Borrowers: *Procurement in Investment Project Financing – Goods, Works, Non-Consulting and Consulting Services (July 2016, revised November 2017, August 2018, November 2020 and September 2023)* and the Bank's *Anti-Corruption Guidelines (revised July 2016)*, and is open to all eligible firms and individuals as defined in the *Procurement Regulations*.
