1. The Republic of Serbia (hereinafter called “Borrower”) has received financing from the International Bank for Reconstruction and Development (IBRD) (the “Bank”) toward the cost of the Serbia railway sector modernization (SRSM) project, and intends to apply part of the proceeds toward payments under the Contract for Reconstruction of railway level crossings. This contract will be jointly financed by the Agency Francaise de Development (AFD). Bidding process will be governed by the World Bank’s Procurement Regulations. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank’s Disbursement Guidelines for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.
2. The Ministry of construction, transport and infrastructure (MCTI) now invites sealed Bids from eligible Bidders for the Reconstruction of railway level crossings, SER-SRSM-RFB-PLANT-24-71.

Scope of work includes design services, reconstruction work, supply and installation of equipment, testing and commissioning, including services related to trainings and preparation of Operational and Maintenance manuals (documentation) for 11 (eleven) RLCs. The RLCs have been chosen based on their current condition and critical importance on the network. Detailed information on locations of RLCs is presented in table below:

Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers dated July 2016, revised November 2017, August 2018 and November 2020 ("Procurement Regulations") and is open to all eligible Bidders as defined in the Procurement Regulations.
4. Interested eligible Bidders may obtain further information from the Central Fiduciary Unit of the Ministry of Finance and inspect the bidding documents from 09:00 to 15:00 hours at the address given below.

The bidding document in English may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of **EUR 50.00** or equivalent in Serbian Dinars (RSD) based on the selling exchange rate published by the National Bank of Serbia on the date of payment.
