- 1. The Republic of Serbia (RoS) has received financing from the World Bank toward the cost of the Western Balkans Trade and Transport Facilitation Project (WBTTF), and intends to apply part of the proceeds toward payments under the Contract for Procurement of Design, Supply and Installation of Equipment to Increase Safety at Railway Level Crossings. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing, except for those payments, which the Contract provides to be made through letter of credit.
- 2. The Ministry of Construction, Transport and Infrastructure (MCTI) now invites sealed Bids from eligible Bidders for:

Lot 1 - Design, supply, installation and commissioning of equipment for RLCs, I group Lot 2 - Design, supply, installation and commissioning of equipment for RLCs, II group

The aim of this bid is to carry out services and works for railway level crossings (in total 58) identified as weak points in rail infrastructure that significantly jeopardize traffic safety and efficiency in Serbia. The Contractor shall undertake the design services, minor civil works, supply and installation of equipment, testing and commissioning, including services related to Trainings and preparation of Operational and Maintenance Manuals (documentation) for the below listed RLCs:

Lot 1 (36 railway level crossings):

- Ruma-Sabac-branch-line junction Donja Borina state border (Zvornik Novi),
- Belgrade Centre Pancevo main Vrsac state border (Stamora Moravita),

It is anticipated that the Contract will start in October 2024 with maximum duration of 18 months and Defect Liability Period of five hundred and forty (540) days.

3. Bidders may Bid for one or several contracts, as further defined in the bidding document. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so provided those discounts are included in the Letter of Bid.

Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" (July 2016, revised November 2017) ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
